SANCTION: This contest is sanctioned by the National Physique Committee (NPC) of the USA, Inc. Sanction # 10024.

TIM GARDNER EXTRAVAGANZA ELIGIBILITY: Open to all NPC competitors Nationwide (Level IVA). NPC membership cards can be purchased at registration. Athlete is not eligible with an open overall victory within the same discipline of a level IVA contest or higher.
